You can call or leave a Message at (403)335-4494 (office phone) Anyone under the age of 18 must be accompanied by an adult
- 2. Please sign in by completing the information on pg.1 and drop in drop box located near the regular member sign in sheet, EVERY TIME YOU RIDE in our arena. Payment Envelopes are provided.
- 3. The information you provide allows us to track usage of our facility
- 4. Riders are responsible for cleaning up MANURE, both INSIDE THE ARENA AND OUTSIDE THEIR TRAILERS!
- 5. No GLASS BOTTLES of any kind in the arena area.
- 6. The Ag Society calendar is kept up to date and MUST be followed to ensure fair usage to everyone. Open riding on designated ride times only (check with the Ag office/or website calendar for current and up to date availability)

- 7. The renter/user shall be responsible to make good all damages incurred during rental/usage period.
